

## Goldberg re-elected, Margo likely; other seat too close to call

As of the *Weekly's* Wednesday afternoon deadline, incumbent Brian Goldberg received 1,106 votes, Frances Bilak received 619 votes, Lewis Hall received 571 votes, and Andy Licht, who dropped out of the race, received 499 votes.

No votes have been counted yet for write-in candidate Noah Margo, because write-in votes are not counted until after the official canvass of election returns begins today. Approximately 1,750 ballots identified as containing write-in votes have not yet been counted, most of which are likely to be for Margo. The top three candidates will be elected.

According to Executive Liaison Efrain Escobedo at the Los Angeles County Registrar-Recorder/County Clerk's office, approximately 1,200 Vote by Mail ballots identified as containing write-in votes were set aside and 551 ballots cast at the polls were identified as containing write-in votes and were set aside. The County had also not yet counted 105 Vote By Mail ballots that

were returned at the polls or received by the County on Tuesday, and 70 provisional ballots. Ballots received Wednesday will not be counted.

"It's the most significant write-in campaign this election," Escobedo said.

Though Escobedo could not identify specific precincts where this occurred, he said there were some precincts in Beverly Hills in which every ballot contained a write-in vote.

Registrar-Recorder/County Clerk spokesperson Marcia Ventura said write-in votes have to go through a verification process to make sure that ballots with write-in votes do not cast votes for more candidates than the maximum allowed. The eligibility of voters who cast provisional ballots must be verified, as well as the signatures on Vote By Mail ballots that were returned at the polls or received at the County on Tuesday.

When Mayor Barry Brucker was first elected to the Board of Education as a write-in candidate in 1997, a preliminary count of write-in votes was reported the Thursday after the election. Receiving a little over 1,500 votes, Brucker led the six candidates that year.

Goldberg expressed gratitude to the community for providing him the opportunity to serve another term.

"I'm very appreciative of all the votes and of all the people who volunteered and helped get me re-elected," Goldberg said.

Goldberg said the difference between his 2007 and 2011 campaigns was "the overwhelming support and the volunteers that came out to host coffees, to walk with me, to make phone calls, just helping every aspect of the campaign. It really was a large grassroots effort that was very rewarding to me because it said people were very pleased with my four years on the board and my record."

Margo said he was trying to keep busy while he waited for the results.

"I am trying to surround myself with friends and distractions and work so that I don't think about this until I get the results," Margo said. "Otherwise I'm feeling very positive. I got great feedback from everybody; we'll see what happens."

Bilak agreed it was difficult waiting for results.

"I'm enthusiastic so far about the results but of course we have to wait and see what the rest of the results are," Bilak said. "I'm very excited about the whole process. I'm happy about having gone through it all. I'm so glad that I met so many people in the community."

Hall said he was not thinking too much about the results.

"We just have to wait and see how this turns out," Hall said. "Overall, I'm pretty happy with how I did, given the fact that I spent basically no money and I didn't have the amount of contacts that many people



### Israel, Jordan trip a historic adventure for the Golds

In a visit that coincided with Sukkot, Councilmember Julian Gold and Michele Gold traveled to Israel and Jordan last month to spend time with their daughter, Rebecca Gold, who has been studying abroad at the Hebrew University in Jerusalem.

Upon the Golds' arrival, Rebecca, who is a junior majoring in psychology at Carnegie Mellon University, ushered her parents around Jerusalem, where they visited the religious and historic monuments in the Old City, including the Western Wall. The family's next stop was Tel Aviv, and from there, Gold said a tour guide took them counterclockwise around the country to various destinations, including the bunkers of Golan Heights, the Dead Sea at Eingedi, and the mountain-top fortress at Masada.

The last time Julian visited Jerusalem was in 1977, when the Yom Kippur War was still fresh in his mind.

"Obviously the old part of Jerusalem is the same—it has been that way for centuries—but the areas surrounding it have just grown dramatically, and certainly Tel Aviv has [become a] sprawling international city," Gold said. "When I was there before, there were still embankments and soldiers with heavy automatic weapons all over the place protecting people. Today you still see soldiers [but] it's not the same kind of intense military feel that it was [about] 30 years ago."

Even during Gold's most recent trip, he described a disquieting feeling he had while crossing into Jordan to visit Petra, the rock-cut city and archaeological wonder.

"It's a little spooky because on one side you have the Israeli soldiers and passport control and then there are maybe 100 yards of road and not much else, and you pass through the Jordanian passport control with their soldiers," Gold said.

Despite feeling unsettled crossing into Jordan, Gold said visiting Petra was one of the trip's highlights because of its "stunning visuals."

"[You see] these huge steep cliffs and it finally opens into this clearing where they've carved this temple," Gold said.

Another highlight for Gold was the Old City in Jerusalem.

"There is nothing like the Old City of Jerusalem," Gold said. "It's a very spiritual place. It is the birthplace of humanity as we know it. It's holy in multiple religions and despite the differences amongst the religions, the intensity of the spirituality and the sense of history is really overwhelming."

The Gold family happened to be in Israel during two events of modern history: the release of Israeli soldier Gilad Shalit and the death of Moammar Kadafi.

"I think there was huge excitement over the fact that [Shalit] was coming home," Gold said. "People were thrilled to get a glimpse of him on TV and know that he was okay. The country was united around this kid; it was refreshing to see that."

Gold said excitement about the news of Kadafi's death was also noticeable, but "it didn't come close to the energy that we saw with Gilad coming home."

Gold said he thinks everyone, if given the opportunity, should travel to Israel.

"It gives you a perspective on our world today," Gold said. "It gives you some understanding of how we got to where we are."

Though Goldberg felt confident, he said he was a bit anxious waiting for the final results.

"For people that thought this was going to be a boring election, it turned out it was quite an exciting election, with people dropping out, with a write-in [candidate]," Goldberg said. "The election ended up being a lot more suspenseful than any of us

wanted it to be."

### Council says Trousdale Estates view restoration ordinance needs refinement

Following a two-and-a-half-hour discussion of the proposed view restoration ordinance for Trousdale Estates, the City Council decided to continue the item to the next meeting on Nov. 15. In the interim, City Attorney Larry Wiener will refine language and details in the ordinance that were

of most concern to councilmembers and residents that attended last Thursday's City Council meeting.

The items of concern were:

- The ordinance's indemnification clause, which was intended to make the ordinance cost-neutral to the City as directed by the City Council, but imposes a significant financial burden on residents

- Language in the ordinance about enforcement stating, "If a foliage owner fails to comply with the provisions of a view restoration permit, the City may [not "shall"], at its discretion, enforce its decision"

- Parameters of the safe harbor plane, which would be used to exempt from the ordinance foliage that could be reasonably seen not to block views

The proposed indemnification clause states, "View owner shall indemnify the City against any and all claims resulting from the issuance, defense, implementation, or enforcement of the view restoration permit," requiring the view owner to reimburse the City for any court costs and attorney's fees related to challenges to the view restoration process.

Planning Commissioner Brian Rosenstein, who addressed the City Council during public comment, called the indemnification

clause unfair to residents. The Planning Commission spent many meetings drafting the ordinance that came before the City Council.

"This indemnity language is the kind of language we make developers and corporations agree to when they are going through an approval process here in the City," Rosenstein said. "The difference is, the developers are doing this to make money. Most of our residents would go through this process to restore their quality of life."

Rosenstein proposed placing a cap—\$100,000 was his own recommendation—on the potential cost to a resident as a result of a challenge to the City's decision.

Councilmember John Mirisch expressed concern about the potentially high cost of the program to the City, since the City Council directed the Planning Commission to draft an ordinance that would be cost-neutral to the City.

"While in a perfect world, we would be able to take on that expense, we are in tough times right now," Mirisch said. "We have to make priorities."

The view restoration ordinance was designed to encourage residents to attempt to resolve their view issues first with initial neighbor outreach and mediation, which are

required steps before one can come before the Planning Commission seeking a view restoration permit. Residents also have the option of seeking a non-binding City advisory opinion, which was proposed as an alternative to the potential high cost of the proposed view restoration permit process. Residents would be required to wait at least 12 months before applying for a view restoration permit, to avoid the appearance of a conflict with an earlier City opinion.

Resident Karen Platt took issue that the ordinance said the City "may" enforce the view restoration permit.

"If a person goes through the process, goes through the Planning Commission, appeals to the City Council, and the City Council makes the decision, then are you going to say you're not going to enforce your own decision?" Platt said.

On Monday, Mayor Barry Brucker said that was not the intent.

"We [will be] utilizing some words that allow for some extraordinary event that could be called into question," Brucker said. "However, we needed to clearly define that the 'shall' means exactly that, that the determination will be enforced in full."

The third main point of concern was the maximum height of foliage that would not be subject to the ordinance, proposed in the draft ordinance as 14 feet. Resident Sharam Melamed presented graphs demonstrating that many areas in Trousdale Estates are graded at 11 feet and many homes are barely 14 feet, the maximum allowable height for structures, above their downslope neighbors.

Melamed said if a homeowner is allowed to maintain foliage at 14 feet, it could block the uphill homeowner's view.

Melamed said he supported the Planning Commission's suggestion to define the safe harbor plane by points that are one foot above the roofline of the foliage owner's home, allowing foliage to grow to a maximum of 15 feet if a home is 14 feet tall. Vice Chair Craig Corman and Commissioners Noah Furie and Rosenstein made the recommendation at the meeting, though it was not included in the draft ordinance. All five councilmembers expressed support for the recommendation.

One resident commented that the City's pine trees on Loma Vista also impact residents' views, but City trees are not subject to the proposed ordinance.

"It would not be a bad idea to send this issue to our Recreation and Parks Commission and let them evaluate the trees and get an assessment from an arborist as to the nature and scope of what the trimming versus removal might cost and see whether that's something the council wishes to further address," Brucker said.

### City, school district explore options for Beverly High oil well site

Councilmembers Lili Bosse and Julian Gold met with Board of Education member Jake Manaster Oct. 31 to discuss options for replacing the revenue from the oil well on Beverly High's campus after the lease with Venoco expires on Dec. 31, 2016. Board member Steven Fenton, who was also appointed to the City Council-school

board ad hoc committee, was unable to attend because of a business commitment. Currently, the oil well at Beverly High generates approximately \$1 million in revenue for the City and the BHUSD.

"We saw what the potential mitigation of that property might look like and the time frame based on potential land uses," Gold announced at last Thursday's City Council meeting. "I think that the ongoing discussion will look not only at replacement of that revenue but hopefully create something that might over the course of time generate more than what the replacement revenue is."

The committee studied a draft report prepared by AECOM, a consultant to the City of Beverly Hills that provided case studies of actual facility redevelopment projects, as well as a list of potential uses and estimated amount of time it would take to prepare a site to support a particular use. Depending on the type of use, the range appears to be one to nine years. While it could take less than four years to ecologically restore the site, prepare the site for a parking lot, public park or athletic field, uses requiring four to nine years to prepare include constructing an office building, apartment building or school facilities on the site.

"We [had] a very good dialogue about the fact that there can be revenue opportunities that can come out of this, but it will take some time to formulate," Manaster said.

Though the school district and City will continue to earn revenue from the oil well until the lease ends in 2016, Manaster said it was imperative that the committee comes up with a plan early, since it could take several years to prepare the site for another use. Manaster said his goal is to formulate plans A, B and C in the next year.

The committee also briefly discussed the possibility of slant drilling, which allows drilling at an angle from a location not directly above the targeted site. The City plans to contact Venoco to ask about the life expectancy of the oil well and the feasibility of slant drilling from the existing oil well. The City Council passed an ordinance Sept. 27 prohibiting drilling and extracting oil, gas and other hydrocarbon substances from surface locations in the City. The ordinance does not ban slant drilling, which is permitted as long as the drill site originates outside of City limits and at least 500 feet away from a Beverly Hills school or park property.

"We discussed a few options in terms of revenue producing [alternatives]," Bosse said. "One of them was the feasibility of

slant drilling, but we didn't give that any more importance than other alternatives we discussed, [including] apartment buildings, office buildings, or other methods of revenue for the schools and the City."

The committee plans to meet again in about a month.

### Brucker calls for City-school district liaison subway meeting

Mayor Barry Brucker announced at last Thursday's City Council meeting the City is working on setting up a meeting between the city council and school district liaisons to discuss Metro's seismic and geotechnical data, options for sharing collaborative data and potential joint legal strategies and opportunities.

Expressing disappointment about Metro's recently released seismic and geotechnical data reports, which recommended a subway route that would involve tunneling under Beverly High, Brucker said he is launching a mayor's task force, led by Vice Mayor Willie Brien and Councilmember Lili Bosse, to vet Metro's data and explore legal and joint defense options with the school district. Bosse and Brien would represent the City Council in a meeting with the school district liaisons, Brucker said.

The Board of Education reached out to the City multiple times in the past in an effort to form a joint defense agreement, but Brucker maintained that he wanted to take a diplomatic approach by meeting with as many Metro board members as possible. City Manager Jeff Kolin sent a letter on Sept. 28 declining the school district's most recent invitation. In early October, before Metro's seismic and geotechnical data report was released on Oct. 19, Brucker said he was open to the idea of a joint defense agreement, but he thought it was premature at the time.

"We've always been open to a discussion [about a joint defense agreement]," Brucker said on Monday. "Whether we get there or not will be determined by the Mayor's task force ad hoc, and what their recommendations may be."

In addition, Brucker announced last week that geotechnical engineering firms Exponent, Inc. and Shannon & Wilson would do separate independent analyses of Metro's data. The City Council approved their contracts at the Sept. 27 City Council meeting.

"I want to reaffirm that the entire City Council is opposed to the Constellation station route, which means tunneling under our high school," Brucker said.

BHUSD has also retained experts to evaluate Metro's work. In a letter to the BHUSD community, Board of Education President Lisa Korbatov said the experts are also evaluating the safety of existing buildings on campus.

"The initial conclusion of our experts is that the data presented by Metro is not sufficient to support a change in school operations or occupancy," Korbatov wrote. "However, additional evaluation will be required and is ongoing. This evaluation will require on-campus field testing and exploration to either confirm or rebut the Metro conclusions. This testing will be done as quickly as possible without interrupting school activities."

Metro's seismic and geotechnical reports will be included in the Final Environmental Impact Statement/Report, but no final decisions have been made about the subway alignment. The final EIS/EIR is expected to be released this winter.

Korbatov did not return phone calls from the *Weekly*.

**Zusman-Eddy departs Chamber; heads to Dallas**

Though Vice President of Economic Development Anita Zusman-Eddy's tenure at the Beverly Hills Chamber of Commerce just ended, Zusman-Eddy's husband Lockwood Eddy was recently offered a promotion with the Federal Deposit Insurance Corporation. Before the end of the month, Zusman-Eddy, her husband and their four-year-old daughter will be headed to Dallas.

In an e-mail to members of the Chamber's

Economic Development Council on Nov. 3, Chamber Executive Director Alex Stettinski announced that the Chamber and Zusman-Eddy had "come to a mutual agreement for an amicable separation."

Stettinski explained the Chamber has gone through structural adjustments in response to changes to the Chamber's work plan with the City.

"Throughout her tenure, Anita has made valuable contributions to the Chamber, and she will be greatly missed," Stettinski wrote. "We wish her the best for her new future endeavors."

Zusman-Eddy acknowledged she knew the restructuring would affect her position.

"The work plan no longer required the service that I was providing in terms of economic development," Zusman-Eddy said. "The Chamber and I mutually agreed that I would move on to other opportunities."

The timing of Lockwood Eddy's job offer worked out in what Zusman-Eddy called a natural cycle. Upon arrival in Dallas, Zusman-Eddy said she would take some time to help her daughter get acclimated. Eventually, she plans to seek a job in economic development or government affairs.

Zusman-Eddy concurred her departure

"It really pushed my career to a milestone," Shoushani said. "If it wasn't for [King] I wouldn't be able to attract the people that I'm attracting to come to the show."



## And the winners are?

Notes from around the village

So, you want to know who won the school board election? So would we.

Here's what we do know: Dr. **Brian David Goldberg** will come in first by a wide margin, reversing a recent trend to defeat candidates for school board or council when they are the lone incumbent on the ballot.

Based on the numbers of not counted ballots, it seems likely that **Noah Margo** will come in second with **Frances Bilak** slightly ahead of **Lewis Hall** for the third spot.

What is very clear is that far less than 20 percent of eligible voters actually cast a ballot. You can provide your own interpretations: Either the campaign did not really excite the electorate, or voters were convinced that all was well with our schools, and/or that the problems facing the district turned them off.

Issues? Not very many. The only real excitement in the election came when one of the candidates, Bilak, became involved

in an unfortunate dispute with a student host of a school television program. That flap led to a very public withdrawing of support by some of her key endorsers, but not sufficient to actually sink her campaign. She is leading and still a very possible winner.

What was most distracting in this election was the withdrawal of two very viable candidates. First, **Damien Bean** opted to pull out just days before the close of filing. Then **Andy Licht** withdrew shortly after his campaign kickoff, but too late to remove his name from the ballot.

Licht's name on the ballot gave the election some sub-plots. Although there was considerable speculation on the "real" reasons for his decision beyond his explanation that he simply did not feel he would have the time to handle the highly complex issues facing the district, but what would happen if he won anyway?

Three possibilities: The board could

appoint, hold a special election or Licht would agree to serve, responding to what he might describe as a draft by the voters. This latter option had the tacit support of some who were not too excited by the alternatives, and the appointment option by board loyalists who had their own possible candidates.

However, Licht is trailing Lewis Hall and Bilak and we will probably have a winner without the trauma of an appointment process or the costs of a special election.

A cursory examination of the numbers of yet to be counted ballots, and they are considerable, probably close to 1,000, makes it reasonably safe to predict that write-in contender Noah Margo will win election, and come in second.

But he admitted there were problems. Many of his supporters complained that the ballot instructions for write-ins were confusing and the sign-in space too small.

Not all of the uncounted ballots were write-ins. These ballots, called provisional, also include mailed ballots received late, delivered to the polls, possible duplicate votes and any ballots that could not be immediately validated, needing further examination. Some of these could also be write-ins, but probably represent about 15 percent of the not counted.

Again, Goldberg a sure and comfortable winner, Margo a very likely second place, with Bilak and Hall struggling for the third spot. Although it is still mathematically possible for Licht to edge out both Bilak and Hall, and really throw the election into more confusion, that's not that likely.

Polling place locations also added to the confusion. Some of the usual venues, including both El Rodeo and Hawthorne school, were moved or consolidated with new or other locations. The anticipated low turnout led to fewer polling places.

Goldberg, who had declined to be nominated for board chair during the last cycle, deferring to newly elected board member **Lisa Korbatov**, said Tuesday night during the election night program **Josh Gross** and I do on the school's television channel, that he would, if nominated and elected by his colleagues, agree to become the next board president.

What is very hard to justify is the incredible amount of time it takes the County Registrar of Voters to actually count all the ballots. Yes, the agency is responsible for dozens of local elections, some with very complicated issues on counting, but certainly the technology has to be available to provide results far more quickly and efficiently.

As just one example: When we called to find out the actual numbers of ballots counted, we were told that was not yet available. Now, the Registrar has the votes by candidate, how could they not know how many were counted? And why not an early report on the numbers yet to be tallied?

With those figures, the newspapers, the candidates and those directly involved

would have some data on which to make judgments on the final results.

Some of the people who answered the phone late Tuesday at the County were extremely courteous and helpful, but the permanent PR staff are more interested in circling the wagons and quoting the law—which gives the County the statutory ability not to make a final count available for weeks, than speeding up their work.

It is important to know who won, not just because of the anxiety the lack of information creates among candidates, their families and active workers, but because the school district needs to adjust to whatever leadership the voters have selected as early as possible.

All of this points to a suggestion this column has been making for years: Give local communities the option of contracting with their own city clerks to provide election services. Not only would we have speedier information, there would be far less uncertainty on polling places and ballot voting information. We will pursue this far more aggressively now that we have one more county debacle on speedy returns.

Two veteran community leaders and board members will be leaving the board: **Myra Lurie** after two terms and **Steven Fenton** after only one. Although often at odds on education and process issues, both made major contributions to our schools and will be missed. We did admire Lurie's difficult role when colleagues with whom she served either were defeated for reelection or opted not to run again, and she went from a majority voice to a clear, often singular vote of opposition to the new majority. Both merit more space when their terms end.


About Hall: Either he did not or could not raise any real campaign funding, and he was the only candidate without mailers or newspaper ads—it is hard to win without these tools. In fact, in many if not most, of our city elections, the candidates who spend the most are the most likely to win. And that is not as bad as it sounds: Raising donations is also a sign of community support. Hall relied heavily on emails, personal visits and walking. But had he been more out there with campaign tools, he might have won easily. He may turn out to be an excellent board member, and there is a difference between being an exciting candidate, which he was not, and real board serving talents. Although far more visible, with an effective advertising drive, Bilak remains hard to fathom.

As always, the board should continue to provide considerable drama. Good signs: Our new school superintendent, **Gary Woods**, will work with the new board to more clearly define and understand their very separate responsibilities.

The annual Beverly Hills Police Officers Association annual ball, this year under the new management of "2 M Consulting," was a highly successful event, both in terms of attendance and various kinds of sponsorship.

#### **MGM puts finishing touches on N. Beverly Drive office; lease dispute continues between William Morris Endeavor and George Comfort & Sons**

The Architectural Commission granted final approval to the MGM project on the 200 block of North Beverly Drive on Oct. 19. The Commission had granted conditional approval a month earlier on the signage and requested the applicant bring back plans for review.

"We're excited to see [MGM] putting up their signs and continuing their operation in Beverly Hills," Architectural Commission Chair Fran Cohen said.

MGM moved into the building from its Century City location on Aug. 29, and the signs will be the building's finishing touches, Cohen said. The new six-story building had been built for the former William Morris Agency, but the agency, now William Morris Endeavor, never moved in. WME is currently in arbitration with George Comfort & Sons regarding a lease dispute reportedly related to competing agency Gersh's move into the building next door, also owned by George Comfort & Sons, constituting a violation of the lease. WME has reportedly appealed the arbitrator's ruling against the agency.

Michael Federman, attorney for George Comfort & Sons, confirmed the arbitration was ongoing but would provide no additional comment. William Morris Endeavor Spokesperson Christian Muirhead said he would not comment on ongoing litigation.

Eddy would not comment except to say that this had nothing to do with support she received from Chamber execs and staff, even though the whole organization team with whom she had worked has left.

Eddy will be missed. She was a real professional and made a major contribution to our economic sustainability. We will continue to follow the story.

**BULLETIN:** As deadline approached, a very helpful supervisor at the Registrar's Office was able to compile some numbers, and these should have been available from PR staff earlier:

Total number of ballots counted, including mail and walk-in votes, 1,534. Provisional, including ballots marked for write-ins could be well over 1,300. That is lower than expected, but it makes it very difficult, not impossible, for Hall to pass Bilak and Margo now seems assured of a second-place win.

## NIKKIE'S CAUSE

**One year after a nearly fatal accident, Nikkie Sedaghat discusses the danger of carbon monoxide poisoning**

*Now a UCSB student, 2010 Beverly High graduate Nikkie Sedaghat was exposed to carbon monoxide last Thanksgiving at her family's home in Beverly Hills.*

**With temperatures dropping, people in Beverly Hills are starting to turn on their heaters. What tips do you have to avoid the risk of carbon monoxide exposure?**

The gas company provides free annual checkups. I suggest [having] them come in and check all appliances in the house: the stove, the oven, heaters, and the fireplace. I highly suggest getting a carbon monoxide alarm in the house, and something as easy as going to bed with the window cracked open just very small. I know it's cold, but the reason I was affected is because I was locked up in the room with no windows or doors open. Even if there is a leakage of carbon monoxide in a large amount, if there is oxygen flowing in the room you will not be affected. Make sure wherever the heater is in the house, that it's placed where [it won't] clog up, where there's a flow of oxygen [bringing] outside air inside the room.

**It has been nearly one year since your own carbon monoxide incident. Tell us what happened.**

I went home for Thanksgiving [from UCSB]. We had Thanksgiving dinner and I went out with my friends. I got home about 12 o'clock and I live in the back house. I went to bed, and I took some cold medicine because I thought I was catching a cold. I [had] called my mom at 10 o'clock and I told her to turn on the wall heater because the back house tends to get really cold. She turned it on at 10 o'clock; I went in the back house at 12. I was on the phone with one of my friends. I told her, 'I'm getting really tired; I'm going to call you in the morning.' I thought it was the Nyquil making me tired, but it was actually the carbon monoxide that was affecting me slowly.

My mom and I had plans to shop on Black Friday the next morning. As soon as [my mom] realized I didn't come in the house, she came into the back house. Then she tried calling my name. I was not conscious, and she immediately called 911. My dog was in the room. He threw up; he went to the bathroom. She asked me, 'Nikkie, why did the dog throw up and go to the bathroom?' and I didn't respond. She heard me snoring [so she thought] I was breathing. She didn't think anything of it. I wasn't snoring; I was choking for breath. She called 911.

**What happened next?**

They rushed me to Cedars-Sinai. Cedars-Sinai is the one that diagnosed me with carbon monoxide poisoning but they said they couldn't treat me because they didn't have the right equipment. They don't have the hyperbaric chambers. I got rushed from Cedars-Sinai hospital to UCLA. As soon as I got to UCLA, I was immediately put into the hyperbaric chamber. I had hyperbaric treatment three separate times, but after my first treatment, the hospital induced me into a coma for four days, and [then I was in] a regular coma for 31 days.

**What happened during the time you were in a coma?**

They told my mom I only had a 2 percent chance of survival and I was not going to wake up for another year. [They said] if I did wake up, I wouldn't be the same; I wouldn't be able to do the things I could do before. They credit my recovery to my age because I'm so young [18 at the time]. To the best of the doctors' knowledge, they did not know that someone in such a severe coma would wake up so fast. After 35 days I woke up, and it was really hard. I woke up for the first time on Dec. 29 and no one was in the room. I didn't freak out which was weird because I was connected to a lot of machines. Since I was on so many drugs I guess it didn't faze me. I didn't really freak out, but it was still kind of scary. I couldn't talk. I had a [tube] in my throat [since] I had a tracheostomy. It's a procedure [in which] they

cut a hole in your throat for breathing. It was used to catch mucus coming up from my lungs and to help me breathe. When I woke up, I couldn't breathe, I couldn't walk, I couldn't talk. I couldn't do anything.

**Did you have any idea what had happened?**

None whatsoever. The next day, my mom was in the room [when I woke up]. She was sleeping. I was waking up at weird times. I had no idea what day it was, and it was 2 a.m. I said, 'Mom, my stomach hurts.' She freaked out because the doctors told her [I wouldn't be able to talk when I woke up].

Day after day, I couldn't walk. From the day I got into the hospital and the day I left, I lost 23 pounds. I was not eating; I was attached to a feeding machine. The only thing I was eating was a liquid protein shake for breakfast, lunch and dinner. Slowly, my cognition was starting to improve. Every single day I was going through physical therapy, recreational therapy, and speech therapy.

**Have your motor and cognitive skills completely returned?**

I think so. I knew I was perfect when I had my attitude back. I knew it was all there when I could just be spunky and spicy like the way I was before. It took me more than six to seven months to get back.

**What were the challenges?**

I couldn't go back to UCSB for second and third quarter, which really sucked because I had already started [my freshman year]. I already made my friends, started my life. It was really hard because in the beginning there were so many things I wanted to say but I couldn't make out the right words. I had a thought in my head but it wouldn't come out; I didn't know how to make any sense of it. [It was hard] not being able to work out the way I work out. I used to play tennis and I would go to the gym a few times a week. It was really difficult, [but] now I'm back.

**What are you doing to raise awareness about the dangers of carbon monoxide?**

I started a group on campus, an organization called Carbon Monoxide Awareness at UCSB. We just started about three weeks ago; it's very new. I go around to all the sororities and fraternities and raise awareness about the cause. I go to every house. I tell them what they can do to prevent carbon monoxide poisoning from happening and I tell them my story. It's great. As long as I know that I'm doing my job and I'm raising awareness here, it makes me really happy.

I have a staff of 10 to 15 people, my immediate friends who are always willing to help. Second quarter we have a goal to raise money, and with that money I'm going to buy carbon monoxide alarms and install them in homes that don't have alarms.

**How do people respond to your lectures?**

I get a lot of shock. The first question I ask is, who knows what carbon monoxide is? You have half the crowd raising their hands. I explain carbon monoxide poisoning, and everyone's face [expresses] shock and I get a few tears. As soon as I say I was in coma for 35 days, it really shocks people. Everybody knows what carbon monoxide is, [but] nobody knows what carbon monoxide poisoning is. I help them learn what it is and how they can prevent it. It's great. I love that.

**What do you think about the new requirement that every new home in California have a carbon monoxide detector?**

It makes me so happy. I know it wasn't me [alone] that caused this law, but I can definitely say I was a factor. That makes me so happy to know that I played a role in a change. The reason I go to all these homes every week, the reason I talk to people about it all the time is because I know I'm making a difference.

**What are you studying at UCSB?**

I was going into politics before the accident. I was part of Model United Nations here. Part of me wanted to be a politician, be in United Nations or something like that. After the accident and after all the speech therapy I had, of all the therapies I had to go to, I loved going to speech therapy [the most]. I thought to myself how can I really do anything else when my heart is with speech therapy? Now I'm a psychology major with a minor in speech and hearing sciences.

**How have you grown from this experience?**

I definitely think I'm stronger. I am able to overcome difficulties in my life. I look at life in such a different way. I value the smaller things like being able to walk, being able to breathe, being able to eat food, taking care of myself, being able to drive. I was walking with a walker when I first started walking, I was on a breathing machine because I couldn't breathe, I was on an eating machine because I couldn't eat. All of these things [I would] take for granted. I see people drink and drive and I think, what are you doing putting your life at risk?, when my life was almost taken away because I went to sleep.



## BHHS Football Team Loses To Morningside Normans set to conclude season tonight at Nickoll Field against Culver City

The defense of the injury-depleted Beverly High football team drew praise from coach Donald Paysinger, but its offense was unable to score a touchdown for a second consecutive game in a 6-2 loss to Morningside Friday night in an Ocean League game at Coleman Field.

The Norman offense came agonizingly close to scoring, only to have tight end Madison Moore stopped less than a yard from the end zone on a fourth down pass with less than two minutes to play.

Beverly Hills (2-7, 1-3 in league play) was able to avoid its second consecutive shutout on the following play when linebacker Ole Woods tackled a Monarch ball carrier in the end zone for a safety.

The Normans hopes for a comeback victory ended on the first play following the free kick when they lost a fumble.

Quarterback Chad Conner ran 66 yards for the game's only touchdown in the second quarter for Morningside (4-5, 1-3).

"Considering what we had, they played OK," said Paysinger, whose team was forced to play "a bunch of JV kids" because of injuries.

The Beverly Hills defense "played well" and "put us in a position to score. We just didn't do it," Paysinger said.

### What's Next?

The Normans are scheduled to play host to Culver City (6-3, 2-2) at 7 p.m. tonight in an Ocean League game at Nickoll Field.

Junior Chase Crossly, Beverly Hills' third-string quarterback for most of the season, will start, Paysinger said, in order to give the usual starting quarterback, senior Brandon Adams, the chance to be more rested to play safety.

Senior Cameron Countryman will play some at quarterback, along with receiver and defensive back, Paysinger said.

Crossly "can throw the ball," Paysinger said. He completed two of six passes for 30 yards against Morningside.

Crossly joined the program last spring after transferring from a high school in the Palm Springs area, Paysinger said.

Crossly is the front-runner to be the Normans starting quarterback for the 2012 season, Paysinger said.

To defeat the Centaurs, Beverly Hills needs to stop their pass-oriented spread offense and develop a running game, Paysinger said.

The Normans are 0-6-2 against Culver City since 2002, with one loss coming by three points and another by four.

"It would mean everything to beat them," Paysinger said, particularly because a loss would end the Centaurs chances of getting the league's second automatic playoff berth.

The website Calpreps.com projects Culver City will win, 44-19.

The Centaurs were ranked 10th in the Southern Section Western Division poll released Monday.


